On 8 December 2021 the Cayman Islands Stock Exchange admitted to listing the US\$570,000,000 2.771% Series 2021-1 A Fixed Rate Notes due 2046 (the "**Class A Notes**"); the US\$110,000,000 3.571% Series 2021-1 B Fixed Rate Notes due 2046 (the "**Class B Notes**") the US\$36,000,000 6.000% Series 2021-1 C Fixed Rate Notes due 2046 (the "**Class C Notes**" and collectively with the Class A Notes and the Class B Notes, the "**Notes**") issued by the Issuer and the Co-Issuer.

Change of Directors

The Issuer announces that each of Margaret Clandillon and Sean Hinze has resigned as a director of the Issuer as of 14 September 2024 and each of Orla Gillen and Michael Dowling had been appointed as directors of the Issuer.

The Co-Issuer announces that each of Ryan Lecznar and Sean Hinze has resigned as a director of the Co-Issuer as of 13 September 2024 and each of George Douvas and Walter Valarezo had been appointed as directors of the Co-Issuer. The Co-Issuer further announces that Goerge Douvas had resigned as a director on 16 December 2024 and Bruno Saunders has been appointed as a director of the Co-Issuer.

Amendment to Asset Management Agreement and Replacement of Asset Manager

The Issuer further announces that, the Asset Management Agreement dated as of 17 November 2021 (the "**Original Asset Management Agreement**") has been amended by the instrument of resignation, appointment and acceptance dated as of 19 September 2024 (the "**Instrument of Resignation and Acceptance**") in order to remove Navigator Aviation DAC as Asset Manager, and appoint DAE (Ireland) Limited Ltd. ("**DAE**"), a limited liability company incorporated under the laws of Ireland (and an affiliate of the Servicer, having its headquarters at Unit L20-00, Level 20, ICD Brookfield Place, DIFC, Dubai, PO Box 506592, United Arab Emirates, as Asset Manager to the Issuer and Co-Issuer.
