Issuance of Further Acquisition Senior Notes and Working Capital Senior Notes

On 30 August 2023, the Cayman Islands Stock Exchange (the "**Exchange**") admitted to listing up to €100,000,000 Acquisition Senior Notes due 2026 (the "**Acquisition Senior Notes**") and on 28 May 2025, the Exchange admitted to listing €850,000 Working Capital Senior Notes due 2025 (the "**Working Capital Senior Notes**").

The Issuer now announces that there was an increase in the Working Capital Senior Notes from €850,000 to an up to amount of €950,000. In addition, the Issuer now announces that further Acquisition Senior Notes with an aggregate principal amount of €6,497,520.27 ("**Further Acquisition Senior Notes**") and further Working Capital Senior Notes with an aggregate principal amount of €10,726.82 ("**Further Working Capital Senior Notes**"), were each issued with effect from 30 June 2025.

Following such issuances of each of Further Acquisition Senior Notes and Working Capital Senior Notes, €75,161,448.34 Acquisition Senior Notes and €868,872.65 Working Capital Senior Notes were each issued and outstanding at that date.
