Reference is made to the Indenture, dated January 9, 2020 (as amended, modified or supplemented from time to time, the “Indenture”), by and among Carlyle US CLO 2019-4, Ltd. (the “Issuer”), Carlyle US CLO 2019-4, LLC (the “Co-Issuer” and, together with the Issuer, the “Issuers”) and U.S. Bank Trust Company, National Association, as trustee (the “Trustee”). Capitalized terms not defined herein shall have the meanings given to them in the Indenture.

The Issuer hereby announces that the Collateral Manager has informed it that the Collateral Manager and certain Holders of the Subordinated Notes are currently exploring a potential Optional Redemption under Article IX of the Rated Notes to be effected on a Redemption Date to be designated in accordance with the Indenture. In order for the Optional Redemption to proceed, a number of conditions set forth in the Indenture will have to be satisfied. Additional notices and documentation will be provided to Holders as required by the Indenture and related transaction documents. For further information, please contact the Collateral Manager.

Nothing in this Notice constitutes or contemplates an offer of, an offer to purchase or the solicitation of an offer to sell any security in any jurisdiction. This Notice and any non-contractual obligations arising out of or in connection with this Notice will be governed by and construed in accordance with the law of the state of New York.

No person has been authorised to give information, or to make any representation in connection therewith, other than as contained herein. The delivery of this Notice at any time does not imply that the information in it is correct as at any time subsequent to its date.
